2. If sculptors are using pedestals, they must be provided by the artists.
3. Exhibit racks are the responsibility of the artist (no hanging wall spaces).
4. Completed registration form and payment due by **June 1, 2023**.

P.O. Box 243, Brodheadsville, PA 18322 or dropped off at the Township building (Monday through Friday 8am-4pm).
5. Spaces (inside 6' x 9') will be designated as applications are received.
6. Artists are responsible for insuring their work during the exhibition.
7. Works will be available for sale with no commission on works sold.
8. No artwork is to consist of nudity and/or offensive content.
9. Works may be set up starting at 10:00am the day of the event.
10. All artists must have works on display for the duration of the event.
